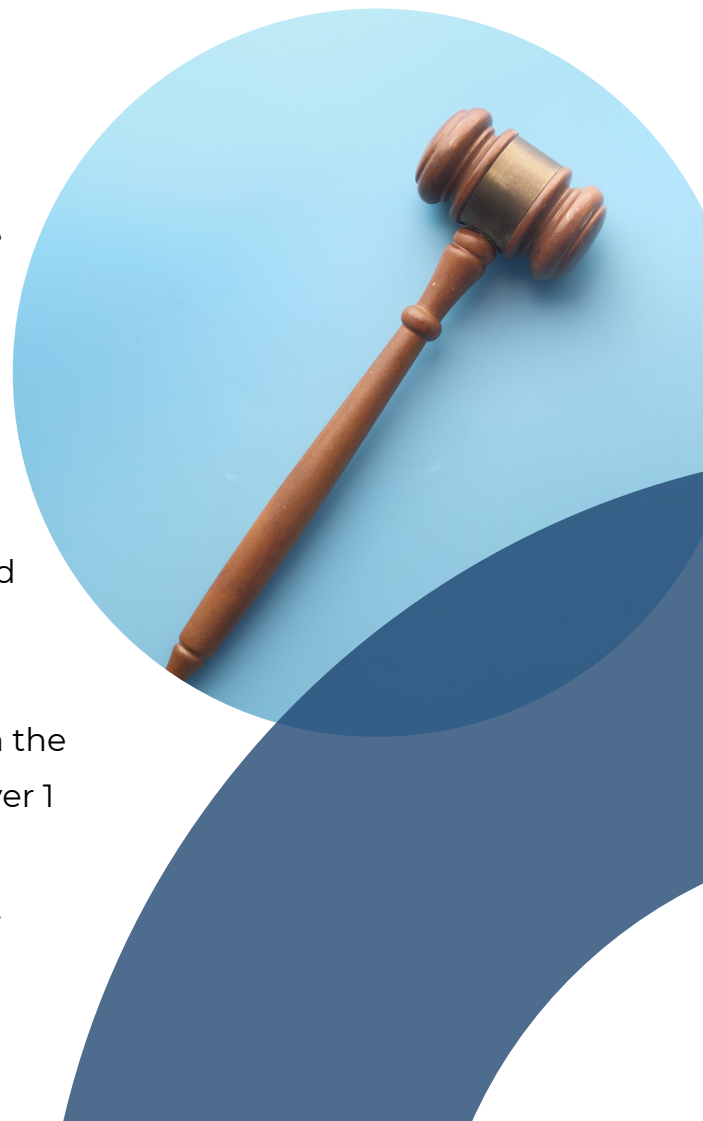

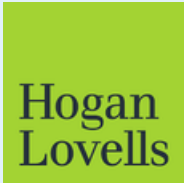
When one of the industry's largest intellectual property firms obtained several thousands of Japanese technical documents, it contacted Morningside to assist in the translation of all the materials into English.
